

1. EXECUTIVE SUMMARY

Project Description:

The scope of the construction work includes the followings:

- The removal and disposal of existing roadway pavement, curb and gutter and sidewalks, milling of existing asphalt pavement to the extents shown on plans.
- The resurfacing of existing asphalt pavement using 2" Superpave AC surface on 14th Street between Thomas Circle and Florida Ave as shown in the plans.
- The replacement of all curbs and gutters with Granite Curbs, 12" Brick Gutter, Concrete Sidewalk, Wheelchair/Bicycle Ramps, and Cobble Stone LID Paver, Bioretention Planters as shown on the plans or as directed.
- The removal and transportation to storage yard of Existing Traffic Signals and Light Poles as shown on plans. Traffic signal relocation and equipment upgrading of Traffic Signals at all intersections of 14th Street within the project limit as shown on plans.
- Streetscaping throughout the 14th Street corridor as shown in the plans.
- The installation of traffic signing and permanent pavement markings.
- Upgrading of street lighting throughout the 14th Street corridor as shown in the plans.
- Construction and upgrading of single catch basin, double catch basin, and triple catch basin.
- Construction / Upgrading of new Watermains, Fire Hydrants
- Full Reconstruction of R Street.
- Installation of new Bus Islands and bus pads as shown on the plans and as directed.
- The installation and use of erosion and sediment control measures as required.
- Mobilization and demobilization, performance of field layout, provision and maintenance of engineer's field facilities, progress photographs, and the proper maintenance of vehicular and pedestrian traffic during construction, including provision of all required construction warning and detour signs and traffic control devices.

2. STATUS OF CONSTRUCTION / PROGRESS SUMMARY

- 1. DEN Building trench drain in front of Riggs and sidewalk.
- 2. Electricians Continue with work on Light poles and pulling cable
- 3. FMCC electrical continue pulling fiber optic comm cable and getting signal
- 4. Verizon moving the two manholes near R street, work has been delayed by FMCC because they are working on opposite lanes
- 5. Landscapers- Cooper continue demobilized, FMCC has work for them to complete what is not finished yet
- 6. Omni working on additional Water Tie ins- uncovering and preparing fo rteh next one
- 7. Omni has begun building brick manhole in front of Winmar development (North of R street west side),
- 8. FMCC continued working on bike racks, benches and trash cans

5. DAILY WORK PERFORMED

Monday 11/25/2019

FMCC placed, water filled jersey barriers (222 LF), traffic drums, cones and arrow board at 14th & Riggs St to R St for Omni Excavators trench work and D.E.N. excavation for sidewalk replacement. Bike racks (5), benches (12) and litter baskets (6) were installed from Corcoran St to Wallach St.

FMCC installed #7 & #4 conductor cables at 14th & U St and pulled cable into traffic cabinets. 2nd Crew worked between R and S St installing 3,650 LF of 12 strand fiber optic cable and (24) push button units at T, V and Fla. Ave. Crew installed LED modules at L121 & L122, countdown modules, 2 and 3 section traffic signal heads at L121 & L122.

Omni Excavators worked at new sewer manhole trench near CB18 to MH-09 excavating and exposing existing sewer pipe. 2nd crew installed 2-4" PVC conduit at Pepco feeder P08 to M63 at Swann St (34LF) and P10 to M76 at Wallach St (11LF) and encased conduit with Class E concrete.

D.E.N. was onsite replacing sidewalk from 1714 to 1724 14th St and installing building entrance ramp at 1722 14th St. Backfill for bio-retention planters were done today at Wallach and Corcoran St as well as permeable pavers at various locations from P St to Corcoran St.

FMCC Paving crew was on site to continue paving the northbound (right) outside lane and the northbound (right) parking lane on 14th St NW between Riggs St NW to S Street NW and the S Street tie in east of 14th Street NW. The Asphalt Temperature were found to be in the range of 265 and 295 degrees. Tack coating was placed before asphalt was placed. 128.59 Tons of 12.5 MM Surface asphalt was delivered. Temporary lane markings were 250.00 LF placed on 14th Street NW from Riggs Street NW to S Street and S Street tie in east of 14th Street NW.

FMCC Milling crew was on site and milled 3" off the previously placed 12.5 SM 2" deep asphalt in the NB inside lane to insure a good longitudinal joint at no cost to DDOT.

FMCC Marking Technician placed 250 LF of temporary 4" white edge line, stop bar, and pedestrian crossing on 14th Street NW between Riggs and S Streets and the S Street Tie in.

Tuesday 11/26/2019

FMCC placed, water filled jersey barriers, traffic drums, cones and arrow board at 14th & Riggs St to R St for Omni Excavators trench work and D.E.N. excavation for sidewalk replacement.

FMCC installed #10 & #8 wire at 14th & W St and pulled fiber optic cable at 15th & RIA. 2nd Crew worked between Q and S St installing 1,200 LF of 12 strand fiber optic cable and (4) push button units at N, P, Q and Wallach St. Crew installed LED modules, countdown modules, and 2 section traffic signal heads at TS-51.

Omni Excavators worked at new sewer manhole trench near CB18 to MH-09 excavating and exposing existing sewer pipe. 2nd crew removed steel plates from T to U St and temporarily backfilled trenches.

D.E.N. was onsite excavating and forming interceptor drains near 1722 14th St. Calculation below are measurements for bioretention planter #3 and #4 including 6" HDPE pipe connecting to catch basin at Wallach St.

FMCC Asphalt Division milled the locations listed below 2". FMCC had a cleanup crew including a street sweeper and cleaned up the streets listed below after the milling operation finished each location.

FMCC installed (4) EA bicycle racks on the NE corner of U Street NW and 14th Street NW and formed and (1) bench at 2017 14th Street NW

FMCC Marking Technician placed 1,085 LF of temporary stop bars, and pedestrian crossings in the intersections of Florida Ave, W Street, and V Street with 4" temporary tape

FMCC Marking Technician placed 535 LF of temporary 4" yellow centerline marking between NB and SB lanes of 14th Street NW between Florida Ave and V Street

Wednesday 11/27/2019

FMCC placed, water filled jersey barriers, traffic drums, cones and arrow board at 14th & Riggs St to R St for Omni Excavators trench work and D.E.N. concrete work.

FMCC installed #4 wire at 14th & N, P, Q & R St.

Omni Excavators worked at new sewer manhole trench near CB18 to MH-09 installing reinforcement and a mat foundation for sewer manhole base using Class E concrete.

FMCC installed (3) bicycle racks 2125 14 Street NW, (1) EA bicycle Rack at 2017 14th Street NW (2) EA bicycle racks at the SE corner of 14th Street at W Street .

FMCC cleaned up and secured the project for the Thanksgiving Holiday weekend.

D.E.N. was onsite placing concrete at interceptor drains (16.5 + 11) near 1722 14th St including adjustment of existing sewer manhole connecting 6" HDPE pipe



Work was completed today at 12pm due to Thanksgiving holiday work restriction implemented by DDOT.




